

Fund Strategy

The fund aims to achieve long-term capital appreciation by investing primarily in equity securities of Asian companies whose business is likely to benefit from growth in domestic consumption in Asian economies. We believe there are ample investment opportunities to be found by tapping into the megatrends within the consumer space, such as Digitalization, Wellness, Premiumization (the shift towards more expensive premium products), New Experience and Urbanization. The team makes use of a bottom-up, selective approach to invest in companies that display sustainable leadership and competitive advantages, while trading at a discount to our view of fair value. Environmental, Social and Governance (ÉSG) considerations are fully integrated in the investment process.




